Be a Part of our History by using your creative mind to construct a quilt that reflects the theme of our 2010 Challenge - *Let's All Go Green* See challenge guidelines & entry rules below.

**Only registered entrants are eligible to participate.**

1. You must purchase a \$ 15.00 challenge packet from Once Upon A Quilt in order to submit your entry.
2. There will be a \$13 non-refundable entry fee.
3. Quilt must only have one maker and only one entry from each person will be accepted.
4. The design of your quilt may be original, traditional or a combination of both.
5. Your quilt may be pieced and/or appliquéd, and embellished in any way you desire.
6. The finished size of your quilt must be 30" X 30" bound.
7. A recognizable amount of the challenge fabric and a minimum of 25 of the challenge beads (found in your packet) must be used.
8. You can add as many fabrics as you wish but **you can not add any green fabrics.**
9. All entries must be constructed of fabric and quilted by hand or machine by the maker.
10. No tied, cheater cloth or pre-printed quilts will be accepted.
11. A four-inch sleeve for hanging must be attached to the top of quilt.
12. Your name must be permanently attached to the back of the quilt, and covered with a piece of fabric that is whip stitched in place.
13. One Color photo size 4 X 6 must be attached to the entry form.
14. Quilts will be judged on workmanship, creativity, design, use of color and interpretation of the challenge theme - *Let's All Go Green*
15. **February 10th, 2010- ENTRY FORM DEADLINE!** Final day entry forms must be postmarked
16. Entries must be received in a cloth white pillowcase, and this casing must be permanently marked with the entrant's name, address and telephone number. **Entry due dates are March 12th & 13th**, if the entry will be shipped, it is strongly suggested that the entry and its casing be enclosed in plastic before being boxed for shipping. Be sure to remove all old shipping labels from your carton. **Please do not use foam or cellulose "peanuts". Your entry will be returned in it's original box.** A pre-paid return shipping label and insurance from Fed Ex ground is the responsibility of the entrant. If not enclosed your quilt will be held for pick up. Be advised that QSBTS will use only Fed Ex Ground to return entries. 17. If the quilt is to be picked up by or return shipped to a person other than the one listed on this form, the show management must be informed in writing as an addendum to this entry form.
18. Any challenge entry not adhering to guidelines will be disqualified.
19. Taxes, if applicable, are the winners' responsibility.
20. Judge's decisions will be final.
